 THE HOME OWNERSHIP PROGRAM THROUGH VOLUNTEER LABOR AND DONATIONS OF MONEY AND MATERIALS, BUILDS SIMPLE, DECENT HOUSES IN PARTNERSHIP WITH LOW-INCOME HOMEOWNER FAMILIES. THE HOME OWNERSHIP PROGRAM BUILDS AND SELLS HOMES AT NO-PROFIT WHICH ARE FINANCED WITH AFFORDABLE NO-INTEREST LOANS. THE HOMEOWNERS'S MONTHLY MORTGAGE PAYMENTS GO INTO A REVOLVING FUND THAT IS USED TO BUILD MORE HOUSES. IN ADDITION TO A DOWN PAYMENT, HOMEOWNERS INVEST SWEAT-EQUITY LABOR INTO BUILDING THEIR OWN HOME AND THE HOMES OF OTHERS IN THE PROGRAM. THE ORGANIZATION SOLD SIX HOMES IN FY 2014 AND HAS SOLD 176 HOMES SINCE 1985.

REPAIR HOMEOWNERS ALSO INVEST SWEAT-EQUITY LABOR AND MAKE MONTHLY PAYMENTS ON A NO-INTEREST LOAN WHICH IS DETERMINED ON A SLIDING SCALE BASED ON INCOME. PAYMENTS ARE PAID FORWARD INTO A REVOLVING FUND TO REPAIR MORE HOMES. IN FY 2014, THE ORGANIZATION RERPAIRED 89 HOMES.
